Gujarat Livelihood Promotion Company Ltd. (SRLM Gujarat) invites Project Proposals as Captive Employers under DDUGKY 2.0 from registered and eligible Project Implementation Agencies (PIAs) having Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD), GoI to allot target of skilling of **2,250 beneficiaries for the period of 2026-28.**

Applicant PIAs should read and understand the DDU-GKY 2.0 guidelines and SOP before applying. The guideline and SOP are available on the MoRD website at <https://kaushal.rural.gov.in>. The appraisal will be done as per DDU-GKY program guidelines, SOPs and MoRD notifications. Captive Employers with PRN having in-house manpower requirement are encouraged to apply at <https://kaushal.rural.gov.in/> under this EOI as Captive Employer category.

1. The interested Project Implementation Agencies (PIAs) may submit their proposals online from **19.08.2026 to 08.09.2026 on www.kaushal.rural.gov.in.**
2. Skill Gap Analysis of Gujarat state has been completed by GLPC and the report of the same is available on www.glpc.co.in which may be useful for the selection of sectors/trades, districts.
3. Commencement of training of the first batch of cycle of projects assigned to respective PIAs must start as per the MoRD's instructions from time to time.
4. Duration of the course to be undertaken must be of such duration so that sanctioned training target is completed on or before **31st December, 2027** and placement or self-gig employment of trained candidates must also begin on or before **31st March, 2028.**
5. Preference will be given to the applicants who satisfies conditions such as (i) provides higher wages or the minimum wage of the Gujarat state for the placement of the trained candidates (ii) mobilize candidates from aspirational districts of Gujarat.
6. The State Project Approval Committee (SPAC) reserves the right to select, reject or modify any applicant and its decision regarding target allocation shall be final and binding on all applicants.
7. Submission of a proposal shall not confer any right on the applicant for sanction or allocation of a training target.

Application received after the scheduled date on the web portal shall not be considered. Incomplete proposal shall be summarily rejected. Please note that only documents uploaded on www.kaushal.rural.gov.in portal will be considered for evaluation.
