OFFICE MEMORANDUM

Subject: Removal of ceiling on the reimbursement of Training Expenses to RSETIs - reg.

The undersigned is directed to invite your reference to para IV(4) of Chapter II of this Ministry's Guidelines for 'Rural Self Employment Training Institutes' (RSETIs), No.I.12011/19/2008-SGSY(C) dated 07.01.2009 the copy of which is available at http://www.nird.org.in/rseti/documents/RSETI_sgsy_Guidelines1.pdf and to say that the Ministry for quite some time have been contemplating on the quantum of training costs to be reimbursed to the RSETIs, presently done through the State Rural Livelihoods Mission(s) concerned.

2. Accordingly, the competent authority in this Ministry has, consequent upon the roll out of LIFE-MGNREGA project, decided to do away with the ceilings mentioned therein and to repeal the contents of para IV(4) of Chapter II of the said guidelines and replace the same with "The MoRD, with effect from 15.11.2015, will provide support towards cost of training for eligible candidates [as detailed in this Ministry's O.M. No. I-12011/03/2016-NRLM (RSETI) dated 16.02.2016] to the sponsor Banks at the rate of Rs. 200/- per candidate per day for the actual duration of the training programme as approved by the concerned authority of the National Academy of RUDSETI [NAR]. Other recurring costs for the RSETIs i.e., that of the training expenses, faculty salaries logistics etc will be borne by the sponsoring banks or through other sponsoring organisations like SIDBI or NABARD etc."

3. The above provisions are applicable only to such courses which commenced on 15.11.2015 and later. This issues with the approval of Secretary (RD).

OFFICE MEMORANDUM

Subject:- Criteria on eligibility of candidates for reimbursement of Training Expenses to RSETIs - reg.

The undersigned is directed to invite your reference to para 11 of this Ministry's "Reimbursement of training costs circular" No. I-12011/06/2011 - SGSY (RSETI) dated 2nd December 2013 [copy enclosed for ready reference] and to say that the Government of India has decided to use Socio Economic Caste Census (SECC) 2011 data in rural development programmes, including the National Rural Livelihoods Mission[NRLM].

2. Accordingly, the competent authority in this Ministry has decided to repeal the contents of the said para 11 and replace the same with " The reimbursement of training costs to the RSETIs shall henceforth be made in respect of all such candidates whose SECC data reflects at least one deprivation factor. Since the SECC data uses the National Population Register's Temporary Identification Number [TIN] for identification of households, the same is to be used in all Rural Development Programmes including that for the reimbursement of training costs to RSETIs. The reimbursement is also admissible to the members of the households identified by the process of Participatory Identification of Poor [PIP] and endorsed by the Gram Sabha concerned."

3. The above provisions shall come into force with effect from 02.12.2015. This issues with the approval of Secretary (RD).
